
VI-1. Change the name of the device

1. Tap the new name of your device and tap OK.




2. Rename your device, then tap OK.

VII. Factory Default

Hardware Reset:

- 1. Press and hold the power button for 10-15 seconds, release the button when the power LED flashes quickly in **blue**.
- 2. When the power LED blinks slowly in blue, it is ready for setup.

1. Click the top right


